**AMENDED CASE MANAGEMENT ORDER**

THIS CAUSE is before the Court on the [217] Motion to Amend Case Management Order filed by Defendant State Farm Fire & Casualty Company. The Court, having considered the matter carefully, finds the motions should be granted in part as set forth herein. IT IS HEREBY ORDERED:

1. **Case Track:** The case is assigned to the Complex Track.
2. **Disclosure:** The initial disclosure requirements are complete.
3. **Early Filing of Motions:** None at this time.
4. **Specific Discovery Provisions or Limitations:**

Interrogatories, request for production and admissions are limited to **30** each.

Depositions are limited to parties, experts and no more than **30** fact witnesses.

Discovery (including deposition testimony) related only to **RICO-specific** claims is stayed until further Order of the Court. All other discovery may proceed.

- \_\_\_\_\_ a. Plaintiff must execute a waiver of medical privilege.
- \_\_\_\_\_ b. Defendant may have a local IME (within subpoena range of Court) with a doctor who has not examined Plaintiff. IME must be completed in time to comply with expert designation deadlines.

5. **Contact Persons:**

6. **Consent to Trial by Magistrate Judge:**

The parties do not consent to trial by Magistrate Judge.

7. **Scheduling Order:**

- a. Deadline for filing motions for joinder of parties or amendments to the pleadings has termed.
- b. ORDERED that the Plaintiff(s) shall designate experts on or before **March 20, 2008.**
- c. ORDERED that the Defendant(s) shall designate experts on or before **June 20, 2008.**
- d. ORDERED that all discovery regarding only the **RICO- specific** claims is hereby stayed until further Order of the Court.
- e. ORDERED that all discovery shall be completed on or before **June 20, 2008.**

- f. ORDERED that all motions other than *in limine* motions shall be filed **by June 7, 2008**. The deadline for *in limine* motions is ten (10) days before the pretrial conference, with responses due five (5) days before the pretrial conference.
- g. ORDERED that a settlement conference shall be set *sua sponte* by the Court or at the request of all parties.
- h. ORDERED that the pretrial conference in this case is **September 12, 2008** before Senior Judge William H. Barbour, Jr.
- i. ORDERED that this case is set for **jury trial during a trial calendar that begins on October 20, 2008 and ends on October 31, 2008**. Estimated time of trial is **2 weeks** (if RICO claims are not dismissed.)
- j. CONFLICTS: Harry Allen and Hunter Twiford have potential conflicts. (The Court will only consider conflicts specified in this Order).
