> **CASE MANAGEMENT ORDER Re:** COORDINATED DOCUMENT PRODUCTION AND DISCOVERY

The Court having considered the establishment of an electronic documents repository for the

purpose of coordinating and streamlining document discovery in actions in which State Farm is a

party, and having invited and received comments from members of the plaintiff's and defense bar,

finds the consensus favors the creation of such a repository in State Farm cases, and enters this

order.

RULES CONCERNING COORDINATED DOCUMENT DISCOVERY

(1) Repository Set-Up

Within twenty (20) days of the date of selection of a vendor as provided in paragraph (4),

a joint electronic repository shall be established and maintained by the third-party vendor in which

the parties governed by this order can, and in some cases must deposit documents produced in

discovery, under the terms set forth in this order.

(2) Purpose of Repository

The repository shall be used to store electronic reproductions of documents that are produced

in discovery, either in response to Rule 34 requests or in connection with Rule 26 voluntary

disclosures, and to permit access to such documents by parties in cases described in paragraph 3.

(3) Parties and Cases Governed

This order applies to the actions listed in Exhibit A, and governs the parties to those actions. Parties in actions filed after the entry of this order may become parties to this order by stipulation of all counsel to the particular action in question, or by application to the Magistrate Judge.

(4) Party Representatives Responsible for Vendor Selection

Within twenty (20) days of the date of this order, counsel in the actions governed by this order shall appoint two representatives – one on behalf of the defendant(s) and the other on behalf of the plaintiffs – whose sole responsibility shall be to select and retain the third-party vendor who will manage the repository, and to coordinate activities as set forth in this agreement. Within twenty (20) days of the date of this order, the parties shall report to the Court the names of the representatives selected or the Court will appoint the party representative(s).

Within twenty (20) days of their appointment, these representatives shall select the vendor to set up and maintain the repository. If the representatives are unable to reach agreement on the selection of the vendor, they shall identify the disputed issues in a motion to be presented to the Magistrate Judge at the expiration of the twenty (20) day period.

(5) Cost of Repository

The cost of the joint electronic repository shall be borne initially by the defendants, as it appears the defendants will reap the greater benefits with respect to a single production of documents for use in multiple cases, and at the outset, only State Farm documents shall be stored in the repository. The Court may re-evaluate both these provisions following a trial period and assessment of the overall utility of the documents repository to the parties.

(6) Submission of Documents to Repository

Documents may be added to the repository in three ways. First, a producing party may elect to deposit documents in the repository. In this event, counsel shall also file in the court record, and serve on opposing counsel, a notice of production of documents to the repository, identifying the Bates ranges of the images deposited. By depositing such documents, and providing such notice, a party will have satisfied its production obligations under Rule 34 and/or Rule 26.

Second, parties to any action covered by this Order may stipulate that documents that have already been produced in hard copy form may be deposited in the repository.

Third, parties other than the producing party may apply to the Magistrate Judge for an order directing that a document that has already been produced in hard copy form be deposited in the repository so that it can be accessed and shared by other parties governed by this order. In ruling on such a motion, the Court shall consider whether the document that is the subject of the motion is relevant to legal or factual matters that are common to the cases governed by this order, and shall deny the motion where concerns of privacy, confidentiality or prejudice outweigh any efficiency gained by the inclusion of the document in the repository. Before bringing such a motion, counsel shall meet and confer with opposing counsel in an attempt to reach an agreement concerning the treatment of the documents at issue.

The parties shall produce documents in an electronic format.

(7) **Confidentiality**

No later than thirty (30) days from the date of this order, counsel for the parties are directed to work together to propose to the court a Confidentiality and Protective Order ("Protective Order") to safeguard, as appropriate, confidential, proprietary, trade secret or private information that may

be produced during discovery. This Protective Order shall be substantially similar to Orders previously entered by the Magistrate Judge in cases involving Defendant and parties represented by counsel for plaintiffs, and shall include the following provisions:

- (a) Documents which have been designated "Confidential" by the producing party may be disclosed only to counsel, counsel's staff and assistants, the parties, and prospective experts, and every such person to whom the documents are disclosed must agree to be bound by the provisions of the Confidentiality and Protective Order, and signify such agreement by signing a form that so indicates as an exhibit to the Order.
- (b) At the close of litigation, copies of all documents marked "Confidential" shall be returned to counsel for the producing party.

In the event that counsel are unable to agree on the terms of such a Protective Order, they shall bring motions with competing orders to the Magistrate Judge.

(8) Access to Repository

Prior to accessing any documents in the repository, counsel for every party to this agreement shall execute the Protective Order and provide a copy of such signed Protective Order to opposing counsel. Once counsel for a party governed by this Order has executed the Confidentiality and Protective Order, he or she will be provided a password that shall be required for access to the repository. The repository shall be designed to track and record by user the documents that have been downloaded or printed and shall permit any party governed by this Order to ascertain which documents have been downloaded or printed by any other party. In order to introduce at trial a document that was accessed from the repository, a party must either have printed or downloaded it

from the repository in the manner permitting tracking outlined above or have notified opposing counsel by Bates number of the documents from the repository that have been obtained.

(9) Numbering and Indexing

The parties to this Order shall develop and maintain a system that identifies by a unique number or symbol each document deposited in the repository, including identification of the depositing party. The parties will solicit proposals from third-party vendors relative to numbering, scanning and indexing the documents produced in this matter.

(10) Documents Produced by Non-Parties

In the event that documents produced by persons or entities who are not parties governed by this Order are included in the repository, the party at whose request production was made shall be responsible for numbering the documents in accordance with the terms of this order.

(11) <u>Legibility of Documents</u>

Each producing party shall take reasonable steps to assure that the copies of the documents it produces are legible. To the extent a producing party cannot or does not produce a legible copy, it shall make the original document(s) available for inspection and copying at the request of any other party.

(12) <u>Authentication</u>

Any document produced by any party via deposit in the repository, whether as part of the initial disclosure, in response to formal document requests, or by agreement, shall be presumed to satisfy the authentication requirement of Fed. R. Evid. 901. This presumption may be rebutted, but the party challenging the presumption shall bear the burden of establishing that the document is not authentic.

(13) Inadvertent Production of Documents

A party that inadvertently deposits in the repository a document that it maintains is privileged

shall, upon becoming aware of the inadvertent deposit, immediately file a notice into the record

identifying the document by its unique number or symbol. Any party seeking to contest the assertion

of privilege must request in camera review of the document(s) in question by filing a motion that

does not disclose the content of the document(s) over which the producing party has asserted

privilege.

No use whatsoever may be made of an inadvertently produced privileged image or of any

information contained therein until such time as the producing party withdraws the claim of privilege

or the Court determines on motion that the document is not privileged. Unless the court overrules

the claim of privilege, any party that received the inadvertently produced document is to immediately

destroy the document and all copies thereof, unless it received the original, in which case it shall

return the original to the producing party.

(14) Preservation

Parties shall preserve evidence in accordance with the applicable law and any orders of the

Court.

(15) No consolidation

The actions that are governed by this Order shall continue to be treated as separate and

independent actions.
