

#### **CHARGES**

The Louisiana Board of Ethics voted on June 14th, 2012 to and does hereby file the following charges:

1.

At a time when Scott Fontenot was contracted as an insurance consultant for Jefferson Parish government, he received a thing of economic value, to wit: **income from Coventry Insurance in 2006**, for or in consideration of services rendered or to be rendered by his spouse Eugenie Fontenot, to or for Coventry Insurance, at a time when Coventry Insurance had or was seeking a contractual, business or financial relationship with his agency, Jefferson Parish government, as defined by La. R.S. 42:1115, in violation of La. R.S. 42:1111C(2)(d).

At a time when Scott Fontenot was contracted as an insurance consultant for Jefferson Parish government, he received a thing of economic value, to wit: **income from Coventry Insurance in 2007**, for or in consideration of services rendered or to be rendered by his spouse Eugenie Fontenot, to or for Coventry Insurance, at a time when Coventry Insurance had or was seeking a contractual, business or financial relationship with his agency, Jefferson Parish government, as defined by La. R.S. 42:1115, in violation of La. R.S. 42:1111C(2)(d).

In accordance with La. R.S. 42:1141C (3)(b)(iv), the Board designates Kathleen M. Allen. Michael Dupree and Aaron D. Brooks as the Board's trial attorneys in this matter.

WHEREFORE, the Louisiana Board of Ethics requests that the Ethics Adjudicatory Board (a) conduct a hearing on the foregoing charges; (b) determine that Scott Fontenot has violated La. R.S. 42:1111C(2)(d) with respect to the foregoing counts; and (c) assess an appropriate penalty in accordance with the recommendation of the Louisiana Board of Ethics to be submitted at the hearing.
