



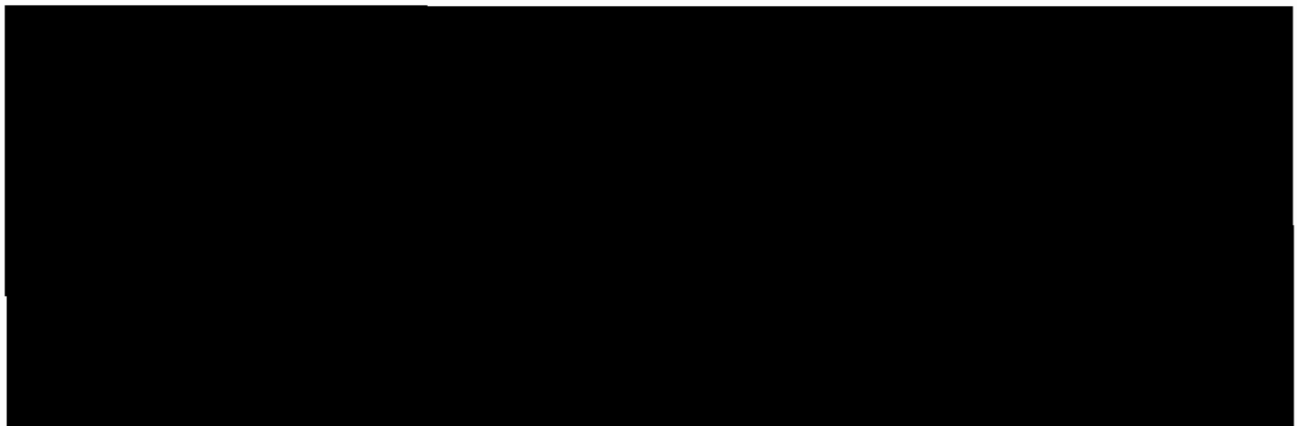

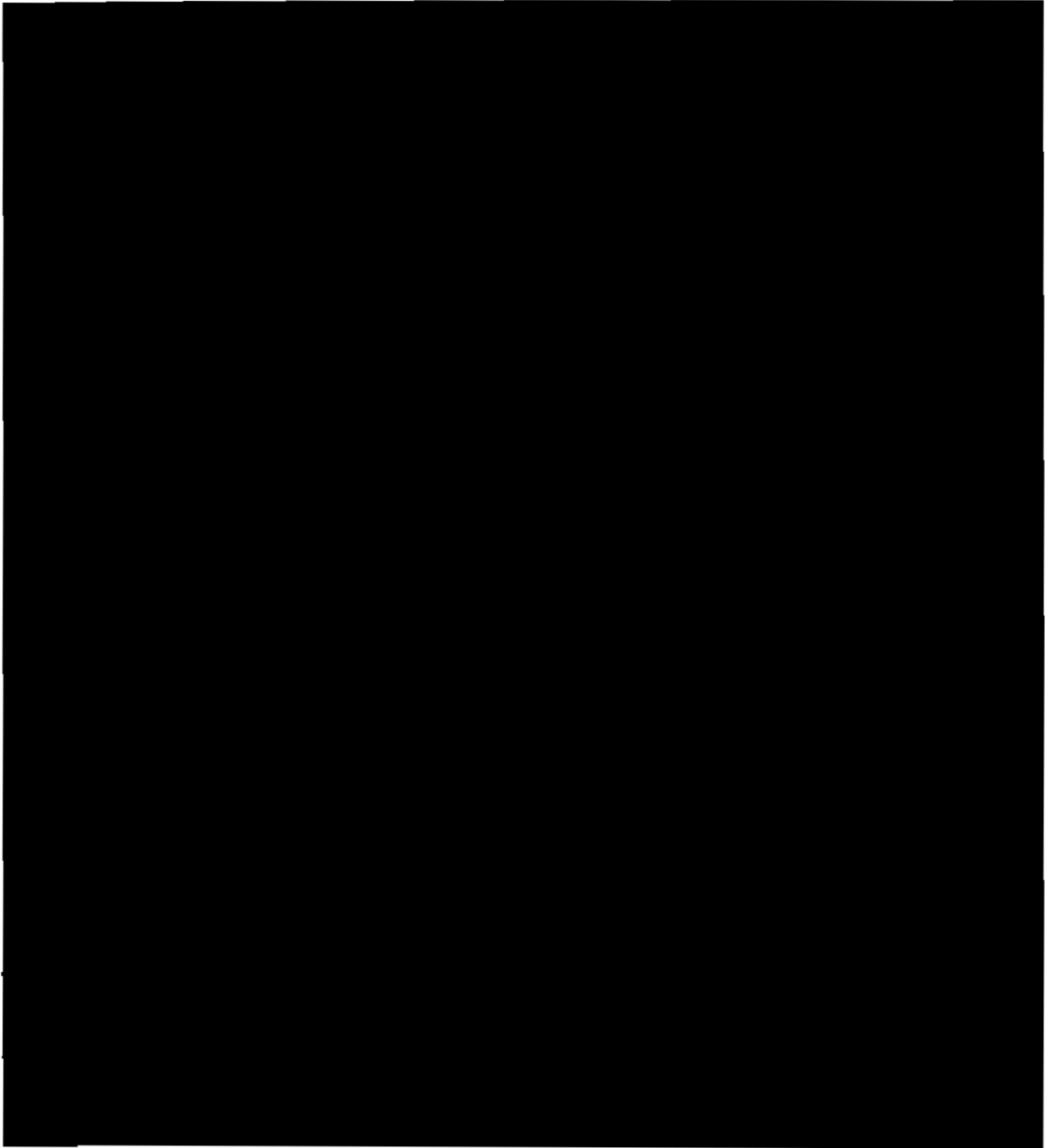

issued forthwith.

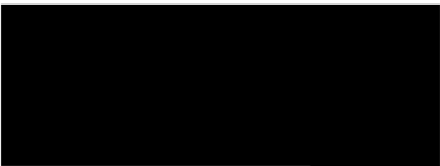
