I

THAT THE FOLLOWING ARE NAME DEFENDENTS:

AFTER WALKING BACK TO TABLE GAMES, BOOM TOWN BOSS SAID WHAT THE HELL IS HE DOING HERE WITH AN OIL SPILL GOING ON. I SAID MUST BE SPENDING CAMPAIGN MONEY ~~FOR~~ TRYING TO WIN A JACK POT. TO PUT IN BANK

BOSS AND I SAID THEY HAD ~~NO~~ - NO PLAN OF ACTION AND THAT WE WOULD LOSE THE INSIDE BAY'S AND MARSH WITH OIL -
