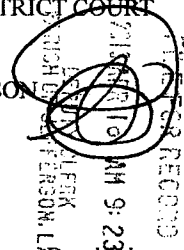

AMENDED MOTION TO ENROLL COUNSEL OF RECORD

NOW INTO COURT, through undersigned counsel, come defendant Nipun Desai who moves this Court for an Order enrolling additional counsel of record. In support of this motion, Nipun Desai respectfully represents:

1.

On April 8, 2013, Desai filed a Motion to Enroll Counsel of Record and Designate Lead Counsel requesting the enrollment of James E. Boren and Rachel Conner as counsel of record along with Desai's current counsel – Lance Unglesby, Daniel Abel and Martin Regan, as well as their associates. Desai additionally requested that the Court designate James E. Boren as lead counsel.

On April 10, 2013, the Court denied Desai's Motion to Enroll Counsel of Record and Designate Lead Counsel, but advised he would reconsider the motion without a request for designation of lead counsel.

2.

Throughout the course of this case, Desai has been represented by Daniel Abel, Pascal Calogero, Frank Desalvo, Gerald Desalvo, Jack Hoffstadt, Logan Greenberg, Martin Regan, Doyle Spell, and Lance Unglesby.

3.

Following the enrollment on attorney Doyle Spell on September 15, 2011, Desai moved to discharge all of his previous attorneys. (Exhibit CRT-0455 – *Court Minutes of 9-15-2011*). Those attorneys included Daniel Abel, Pascal Calogero, Frank Desalvo, Gerald Desalvo, Jack Hoffstadt, and Martin Regan.

4.

On January 5, 2012, Lance Unglesby was enrolled as co-counsel on behalf of Desai. (Exhibit CRT-0529 – CRT-0530), Following Unglesby's enrollment, Doyle Spell moved to withdraw as counsel on January 26, 2012, and was formally discharged by the Court by Order dated March 19, 2012. (Exhibit CRT-0641 – CRT-0642).

5.

On February 7, 2012, Unglesby filed a motion for the enrollment of Daniel Abel as co-counsel to consult on constitutional issues. This motion was granted by the Court on March 8, 2012. (Exhibit CRT-0629).

6.

On October 15, 2012, Logan Greenberg, an associate of Lance Unglesby, and Martin Regan separately moved to enroll as co-counsel for Desai. Their requests were granted by the Court by Order dated October 15, 2012. (Exhibit CRT-0710 and CRT-0711).

7.

On October 19, 2012, Martin Regan filed a Motion to Enroll Counsel of Record for Desai requesting the enrollment attorneys with the law firm of Regan, Littlefield, Thomas & Sandhu, P.L.C. Those attorneys included Martin Regan, Jr., John Thomas, Benjamin Sanders and Joshua Gordon. Regan's motion was granted by the Court by Order dated October 22, 2012. (Exhibit CRT-0713 – CRT0715).

8.

As it currently stands, the following attorneys are enrolled as counsel of record for Desai: Lance Unglesby, Daniel Abel, Logan Greenberg, Martin Regan and his associates: John Thomas, Benjamin Sanders and Joshua Gordon.


9.

Nipun Desai has engaged attorneys James E. Boren and Rachel I. Conner to represent him in this matter, and requests the Court grant their enrollment as additional counsel of record along with Desai's current attorneys of record: Lance Unglesby, Daniel Abel, Logan Greenberg, Martin Regan.

10.



WHEREFORE, Nipun Desai prays this Court will grant the enrollment of James E. Boren and Rachel I. Conner as his counsel of record.


