The Plaintiff admits the allegations in paragraph II in the Counter-Complaint only to the extent that is admits it received a letter from John R. Santa-Cruz on or about June 25, 2013. All remaining allegations of paragraph II in the Counter-Complaint are denied.

#### III.

The Plaintiff denies the allegations set forth in paragraph III of the Counter-Complaint.

#### IV.

The Plaintiff denies the allegations as set for in paragraph IV of the Counter-Complaint.

#### V.

The Plaintiff denies the allegations as set for in the last unnumbered paragraph of the Counter-Complaint.

#### VI.

The Plaintiff denies each and every allegation of the Counter-Complaint not specifically denied herein.

#### VII.

The allegations of the Complaint filed in this civil action filed on August 6, 2013 are incorporated by reference as if fully copied manually herein.

At all material times, the Defendant LNG Investments, LLC was a Mississippi limited liability company. The principal members are the Defendant Lloyd Nicaud and the Defendant Gerald Rigby. The managing partner of LNG Investments, LLC is the Macmillan Group, LLC. Attached as Exhibit "1" is a copy of the Certificate of

Formation issued by the Mississippi Secretary of State confirming The Macmillan Group, LLC is the manager of LNG Investments, LLC.

At all material times, the Defendant Lloyd Nicaud was a general partner and the registered agent of The Macmillan Group, LLC. At all material times the Defendant Mary Bunch was the manager of The Macmillan Group, LLC. The address of The Macmillan Group, LLC is 724 Dunbar Avenue, Bay St. Louis, MS 39520. This is the address of the Defendant Gerald Rigby. Attached as Exhibit "2" is a copy of the Certificate of Formation of The Macmillan Group, LLC issued by the Mississippi Secretary of State.

At all material times, the Defendant Mary Bunch was an agent and employee of the Defendant O'Dwyer Realty, LLC. The Defendant Mary Bunch was the real estate agent for the Plaintiff in regard to the sale of the Bay Tech property by the Plaintiff to the Defendant LNG Investments, LLC, Lloyd Nicaud, and Gerald Rigby. The Defendant O'Dwyer Realty, LLC demanded and obtained a broker's commission related to this sale. The Defendants O'Dwyer Realty, LLC, LNG Investments, LLC, Lloyd Nicaud, Gerald Rigby, and Mary Bunch never disclosed the relationship existing between Mary Bunch and the defendants LNG Investments, LLC, Lloyd Nicaud, and Gerald Rigby. This conflict of interest was never disclosed to the Plaintiff or its principal members by any of the defendants in this civil action.

The Plaintiff affirmatively states as a result of the acts and omissions of the Defendant LNG Investments, LLC, and the illegal and unethical conduct of its managing partner, and co-conspirator, the Defendant Mary Bunch, the Defendant LNG
